## Acting Conservator of the Mersey.

To Admiral Sir A. Mostyn Field, K.C.B., F.R.S., etc., Acting Conservator of the Mersey.

In pursuance of an Act for better preserving the Navigation of the River Mersey (5 & 6 Vic., cap. 110), We, the Wirral Rural District Council, whose offices are at 54, Hamilton Street, Birkenhead, hereby give you notice that we propose to construct at or near the western end of the Wallasey Embankment, in accordance with Plans and Sections deposited at the Office of the Mersey Conservancy, a main drainage outfall for the North Wirral District consisting of a 24" cast iron pipe surrounded by concrete. The whole secured by reinforced concrete piles driven into the foreshore. The concrete casing will be completely embedded in the foreshore for a distance of 900 feet from the embankment and will then project above the surface of the foreshore for a distance of 760 feet, the projection varying from nil at its commencement to 2' 6" at the outlet end of the outfall.

# ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (Dated 2nd September, 1925.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

#### Authorisation of Landing of Animals for Exceptional Purposes.

1. The landing of the animals described in the First Schedule hereto, which are intended for exceptional purposes is hereby allowed subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

# Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a
