such extended limits to exercise all or any of the rights powers and privileges which they now may exercise within their existing limits of supply.

To enable the Council to continue maintain and use any mains pipes and other works belonging to them at the commencement of the Order within the said parishes as if the same had been laid down or constructed under the powers of the Order.

To confer further powers upon the Council in regard to their gas undertaking with respect to the cutting off and reconnecting cf supplies and expenses thereof to require a valve to be maintained by the consumer where high pressure air is used in connection with the supply of gas by the Council and to make better provision with respect to communication pipes between mains and meters and on consumers premises.

To enable the Council to borrow moneys for the costs of the Order and with the sanction of the Ministry of Health for the purposes of their gas undertaking including working capital and to make provision in regard to the borrowing and reborrowing and the repayment of the moneys so borrowed and to enable the Council to use the sinking fund instead of borrowing and to make other financial provisions.

To vary and extinguish all rights and privileges which would interfere with the objects of the Order and to confer other rights and privileges.

To incorporate in the Order and apply with or without amendment all or some of the provisions of the Gasworks Clauses Acts 1847 and 1871 and the Gas Regulation Act 1920 and to repeal alter and extend with or without amend-ment all or some of the provisions of the Sidmouth Gas and Electricity Act 1911 the Sidmouth Urban District Council Act 1912 the Sidmouth Order 1918 and the Sidmouth Gas (Charges) Order 1923 (S.R. and O. 1923 No. 982) and any other Act or Order relating to the gas undertaking of the Council.

Any local or other public authority company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade. Great George Street, London, S.W. 1, and dispatched on or before the 21st day of October, 1925.

Any such objections shall state :---

(a) the specific grounds of objection; and

(b) the omissions additions or modifications asked for.
