Cocking, Easebourne, Heyshott, Linch, Midhurst, South Ambersham, Stedham, West Lavington, and Woolbeding, in the Rural District of Midhurst; and the parishes of East Dean and Singleton in the Rural District of Westhampnett, all in the County of Sussex (hereinafter called "the area of supply").

2. To incorporate with the Order such of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act, 1899, as are applicable to cases in which the Undertakers are not the local authority, and to apply such provisions to the Undertaking to be authorised by the Order, subject to such variations and exceptions as may be contained therein.

3. The streets and parts of streets in which it is proposed that electric lines shall be laid

down within a specified time are :-

Parish of Midhurst:

North Street, Rumbolds Hill, West Street, Knockhundred Row, Church Hill, Red Lion Street, South Street, Station Road (from Petersfield Road to Midhurst Brick Company, Station Yard), Petersfield Road (from Station Road to Ashfield Road).

Parish of Easebourne:-

Easebourne Lane (as far as where the main road enters Cowdray Park).

Parish of West Lavington:— Chichester Road (from South Pond to Taylors Farm).

- 4. The following is a list of the streets and parts of streets not repairable by the local authority which the Undertakers propose to take powers to break up:
- I. Rural District of Midhurst:—

(1) Parish of Cocking:

The main road between Midhurst and Chichester, the road between the two Railway Stations (in Midhurst and West Lavington) of the Southern Railway Com-

(2) Parish of Easebourne:-The main road between Midhurst and Haslemere; Egmont Road.

(3) Parish of Midhurst:

The main roads between Midhurst and (1) Petersfield, (2) Chichester, and (3) Haslemere; the road between the two Railway Stations (in Midhurst and West Lavington) of the Southern Railway Company.

(4) Parish of Stedham:-

The main road between Midhurst and Petersfield.

(5) Parish of West Lavington:

The main road between Midhurst and Chichester; Roadway on bridge, near Oaklands, carrying the road from West Lavington to Cocking Causeway over the Chichester to Pulborough Branch of the Southern Railway, and the approaches thereto.

(6) Parish of Woolbeding:-The main road between Midhurst and Petersfield.

II - Rural District of Westhampnett:-

Parish of Singleton:

The main road between Midhurst and Chichester.

5. To prescribe and limit the price to be charged for a supply of electrical energy.

6. To confer further powers upon Undertakers in regard to the supply of electrical energy to railways, tramways and canals for incidental purposes; and to extend and apply the provisions of section 15 of the Electric Lighting Act, 1909, to the supply of electricity for power purposes to any premises having a separate supply of power whether such separate supply be by electricity, steam or other source of power.

7. To confer upon the Undertakers, with or without variations, all or some of the powers of the Electricity (Supply) Acts, 1882 to 1922, and the enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for

carrying such objects into effect.

8. To make provision for the transfer of the undertaking proposed to be authorised by the Order to a Company registered or to be regis-

tered under the Companies Acts, 1908 to 1917.
