Section 91 (Sky Signs); provided that this section shall not apply to any sky sign erected or to be erected upon any part of the Estate of the Mersey Docks and Harbour Board.

RURAL DISTRICT OF BILLERICAY.

Public Health Acts (Amendment) Act, 1907. Public Health Act, 1875.

BY an Order dated the fifteenth day of September, 1925, the Minister of Health has Declared that, on and after the 2nd day of November, 1925, the following provisions of the Public Health Acts (Amendment) Act, 1907, and the Public Health Act, 1875, shall be in force in the Rural District of Billericay, namely:—

Public Health Act, 1875:-

- (a) In all the contributory places:—Sections 112 and 113.
- (b) In those contributory places in which the provisions are not already in force:—

Such of the provisions of Section 160 as incorporate the provisions of the Towns Improvement Clauses Act, 1847, with respect to naming the streets and numbering the houses.

Public Health Acts (Amendment) Act, 1907:—

(a) In all the contributory places:—

Part II (streets and buildings) except Sections 18, 19, 21, 26, 28, 30, 31 and 32.

Part III (sanitary provisions) except Sections 39, 40, 41, 42, 47 and 50.

Part IV (infectious diseases) except Section 67.

Part V (common lodging houses); and Section 95 (purchase and appropriation of lands) comprised in Part X.

(b) In the contributory places of Great Burstead, Hutton; Mountnessing, Shenfield, South Weald, Wickford, and the South Weald and Shenfield Special Drainage District:—

Sections 39 to 42 (inclusive) comprised in Part III.

The above provisions are declared to be in force subject, as regards Sections 19, 23, 25, 27, 35, 38 and 75 of the Act of 1907 to the conditions specified in the Order.
