The petty sessional divisions of Newnham, Coleford, Lydney, Berkeley, Dursley, Nailsworth, Tetbury, including its detached part, Wotton under Edge, Thornbury (*except the parishes of Redwick and Northwick, Almondsbury and Olveston*) and the parishes of Alderley, Hawkesbury, Horton, Great Badminton, Chipping Sodbury, Old Sodbury, Little Sodbury, Yate and Wickwar.

*In the county of Wilts.*

The parishes of Easton Grey, Sherston, Sopworth, Luckington and Alderton.

7. An Area comprising:—

*In the county of Wilts.*

The boroughs of Malmesbury, Devizes and Calne.

The petty sessional divisions of Devizes (*except the parishes of Tilshead, Marden, Beechingstoke, Alton Barnes and Stanton St. Bernard*), Calne (*except the parish of Yatesbury*), Malmesbury (*except the parishes of Hullavington, Alderton, Norton, Sherston, Luckington, Sopworth, Easton Grey, Foxley, Brokenborough, Long Newton, Ashley, Crudwell, Oaksey and Minety*), and the parishes of Bulkington, Stanton St. Quintin, Draycot Cerne, Kington Langley, Sutton Benger, Langley Burrell Without, Kellaways, Seagry, Christian Malford, Braydon, Lydiard Tregose (*except its detached part*), Wootton Bassett, Tockenham, Lyneham, Lydiard Millicent and such part of the parish of Purton as lies to the south and west of the railway line from Swindon to Minety and also the detached part of the parish of Chippenham Without.

Edburton, Upper Beeding, Botolphs, Bramber, Steyning (including its detached part), Ashurst (including its detached part), Wiston, Ashington (including its detached part), Washington, and the detached parts of the parish of Thakeham.

*In the county of East Sussex.*

The parishes of Twineham, Hurstpierpoint (*excluding its detached part*), Albourne, Newtimber, Poynings and Fulking.

9. An Area comprising:—

*In the county of Southampton.*

The county borough of Bournemouth. The boroughs of Christchurch and Lymington.

The petty sessional divisions of Fordingbridge, Ringwood, Christchurch, Lymington, Romsey (*excluding the parishes of Broughton, Houghton, Bossington, King's Somborne, Upper Eldon, Ampfield and North Baddesley*), New Forest, Hythe, and the parish of Millbrook.

*In the county of Dorset.*

The borough of Poole.

The petty sessional division of Wimborne (*excluding the parishes of Shapwick, Tarrant Crawford, Sturminster Marshall, Almer, Lytchett Matravers and Lytchett Minster*), and the parishes of Farnham, Chettle, Tarrant Gunville, Tarrant Hinton, Tarrant Launceston, Tarrant Monkton and Tarrant Rawston.

*In the county of Wilts.*

The boroughs of Salisbury and Wilton.

The petty sessional division of Salisbury and Amesbury (*excluding the parishes of Orcheston St. Mary, Orcheston St. George, Shrewton, Rolleston, Durrington, Bulford, Cholderton, Newton Tony, Allington, Boscombe, Idmiston, Amesbury, Wilsford, Durnford, Woodford, Stapleford, Berwick St. James, Winterbourne Stoke, Maddington, Steeple Langford and Little Langford*) and the parishes of Sutton Mandeville, Swallowcliffe, Ansty, Donhead St. Andrew, Alvediston, Berwick St. John and Tollard Royal.
