APPOINTMENT OF STANDING FOR TWO HACKNEY CARRIAGES.

By virtue of the Act 13 and 14 Victoria, Chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other Provisions in regard to the Consolidated Offices."

I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for Two Hackney Carriages at Upper Wimpole Street, W., and do make the following Regulations with regard to the Boundaries for the same, viz.:—

In centre of roadway, commencing at a point 15 feet south of the building line at South side of Devonshire Street, extending Southward as far as necessary for two carriages.

Front of vehicles towards the North.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
