## TREASURY BILLS.

- 3. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 15th March, 1926, to Saturday, the 20th March, 1926, inclusive, and will be payable at three months after date.
