Now, therefore, in pursuance of the powers conferred on me by No. 6 of the Raw Opium Regulations, 1921, and No. 12 of the Dangerous Drugs Regulations, 1921, I hereby give notice that I withdraw, as from to-day's date, from the said Dr. Samuel Grahame Connor the authorisations granted by the said Regulations to duly qualified medical practitioners to be in possession of and supply raw opium and the drugs to which Part III of the Dangerous Drugs Act, 1920, applies.
