ORDER OF THE MINISTER OF  
AGRICULTURE AND FISHERIES.

(DATED 28TH APRIL, 1926.)

FOOT-AND-MOUTH DISEASE DECLARATION  
OF INFECTED AREAS ORDER OF  
1926 (No. 65).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

*Contraction of Certain Infected Area.*

1.—(1) The Foot - and - Mouth Disease Declaration of Infected Areas Order of 1926 (No. 62) shall be read and have effect as if the Area described in the First Schedule to this Order were substituted for the Infected Area (No. 6) described in the First Schedule to that Order.

(2) This Article shall come into operation on the third day of May, nineteen hundred and twenty-six.

*Contraction of Certain Infected Area.*

2.—(1) The Foot - and - Mouth Disease Declaration of Infected Areas Order of 1926 (No. 63), as amended by the Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 64), shall be read and have effect as if the Area described in the Second Schedule to this Order were substituted for the Infected Area (No. 7) described in the Schedule to that Order.

(2) This Article shall come into operation on the fourth day of May, nineteen hundred and twenty-six.

*Modification of Foot-and-Mouth Disease  
(Infected Areas) (Temporary Modification of  
Restrictions) Order of 1926.*

3. The provisions of the Foot-and-Mouth Disease (Infected Areas) (Temporary Modification of Restrictions) Order of 1926 and any Order amending the same which authorise movement direct to slaughterhouses in certain towns for the purpose of immediate slaughter, shall, on and after the fourth day of May, nineteen hundred and twenty-six, cease to

apply to the cities of Leeds, Sheffield and Wakefield, and the county boroughs of Huddersfield and Dewsbury, and shall apply only to the city of Kingston-upon-Hull and the county borough of Barnsley.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this twenty-eighth day of April, nineteen hundred and twenty-six.

The parishes of Silkstone, Cawthorne, High Hoyland, Clayton West, West Bretton, Crigglestone, Chevet, Walton, Crofton, Sharlston, Huntwick with Foulby and Nostell, West Hardwick, Hemsworth, Brierley, Cudworth, Carlton, Dodworth, Barugh, Darton, Kexbrough, Woolley, Notton, Royston, Havercroft with Cold Hiendley, Winterset, Ryhill, South Hiendley and Shafton.
