FOOT-AND-MOUTH DISEASE DECLARA-TION OF INFECTED AREAS ORDER OF 1926 (No. 66).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1984 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of Certain Infected Area.

1. The Foot and Mouth Disease Declaration of Infected Areas Order of 1926 (No. 55) as amended by any subsequent Order, shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area (No. 1) described in the First Schedule to that Order.

A Notice of Dissolution of Partnership not signed by all the Partners, or their legal representatives, must be accompanied by a Statutory Declaration made by a Solicitor of the Supreme Court to the effect that such notice is given in pursuance of the terms of the partnership to which it relates,
