#### ORDER OF THE MINISTER OF AGRICULTURE ANDFISHERIES.

FOOT-AND-MOUTH DISEASE DECLARA-TION OF INFECTED AREAS ORDER · OF 1926 (No. 88).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:

### Extension of Certain Infected Area.

1. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 74), as amended by any subsequent Order, shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area (No. 1) described in the First Schedule to that Order.

## Short Title.

2. This Order may be cited as the Foot-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 88).

#### SCHEDULE.

1. An Area comprising:-

In the county of Lanark.

The burgh of Hamilton.

The parishes of Carluke, Cambusnethan, Dalserf, Stonehouse, Lanark, and Dalziel.

Such parts of the parish of Lesmahagow as lie to the north of the following boundary:-Commencing at a point where the road running from Lanark to Coalburn Station via Douglaswater Church and Lintfield Bank joins the south eastern boundary of the parish of Lesmahagow near Douglas Water Church, thence in a westerly direction along the road via Lintfield Bank, Coalburn Station and South Brackenrig to the point where it joins the southern boundary of Stonehouse parish;
