

both in the said County and Diocese, and upon the remaining sides, that is to say, upon the south west and upon the west, by an imaginary line commencing upon the boundary which divides the said Consolidated Chapelry of Saint Ambrose, Whitehall, Bristol, from the said New Parish of Saint Mark, Easton, at the centre of the bridge which carries Devon Road across the Bristol and Birmingham line of the London, Midland and Scottish Railway, and extending thence northward along the middle of Devon Road for a distance of $4\frac{1}{2}$ chains or thereabouts to its junction with Alpine Road, and extending thence westward along the middle of Alpine Road for a distance of $5\frac{1}{2}$ chains or thereabouts to its junction with Colwyn Road, and extending thence northward along the middle of Colwyn Road for a distance of 4 chains or thereabouts to its junction with York Road, and extending thence westward along the middle of York Road for a distance of $4\frac{1}{2}$ chains or thereabouts to its junction with Bellevue Road, and extending thence northward along the middle of Bellevue Road for a distance of $21\frac{1}{2}$ chains or thereabouts to its junction with Robertson Road, and extending thence first westward and then north westward along the middle of Robertson Road for a distance of $7\frac{1}{2}$ chains or thereabouts to the boundary which divides the said New Parish of Saint Mark, Easton, from the said New Parish of Saint Thomas the Apostle, Eastville."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Bristol.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 15th day of July, 1926, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter

55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Michael and All Angels, Mill Hill, situate in the New Parish (sometime Particular District) of Saint Paul, Mill Hill, in the County of Middlesex and in the Diocese of London:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Michael and All Angels, Mill Hill, situate as aforesaid:

"Now, therefore, with the consent of the Right Honourable and Right Reverend Arthur Foley, Bishop of London, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would in our opinion, be expedient that all that part of the said New Parish of Saint Paul, Mill Hill, which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Michael and all Angels, Mill Hill, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Michael and All Angels, Mill Hill.'

"And with the like consent of the said Arthur Foley, Bishop of London, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said Church of Saint Michael and All Angels, Mill Hill, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same Church for the time being. Provided always that so long as the Reverend Edwin Howard Cobb, Clerk in Holy Orders, the present Vicar or Incumbent of the Vicarage of the said New Parish of Saint Paul, Mill Hill, shall continue to be such Vicar or Incumbent, all the fees or dues which may be received in respect of such publication, solemnization or performance at the said Church of Saint Michael and All Angels, Mill Hill, situate as aforesaid, shall be paid over by the Minister thereof to the said Edwin Howard Cobb.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Michael and All Angels, Mill Hill, being:—

"All that part of the New Parish (sometime Particular District) of Saint Paul, Mill Hill, in the County of Middlesex and in the Diocese of London, which is bounded upon the south partly by the Parish of Hendon and partly by the District of Saint Alphege, Hendon, upon the west by the Parish of Edgware, all in the said County and Diocese, and upon the remaining sides, that is to say,
