(D) Railways-

Altrincham Urban District-

The level crossings of the Cheshire Lines Railway (Partington to West Timperley Branch) (1) at the road northwest from Sinderland Lane to Brookside Farm (2) at the road north-east from Sinderland Lane to Brookside Farm.

Altrincham Urban District and Parish of Dunham Massey—

The Sinderland crossing of the London Midland and Scottish Railway (Warrington and Stockport Branch) and the level crossing of the Cheshire Lines Railway (Partington to West Timperley Branch) at Birch Road.

Parish of Dunham Massey-

The level crossing of the London Midland and Scottish Railway (Warrington and Stockport Branch) at Dunham Massey Station and of the Cheshire Lines Railway (Partington to West Timperley Branch) at Brookheys Road.

3. The names of the streets and parts of streets in which it is proposed that electric lines shall be laid down within a period of two years after the commencement of the Order are as follows:—

Parish of Ashley-

Cow Lane from a point 300 yards north of the Police Station to Houghgreen Farm, Back Lane from St. Elizabeth's Church to Backlane Farm.

Parish of Ringway-

The main road from Hale to Wilmslow, Chapel Lane from the boundary of the Urban District of Hale to Yewtree House, and Brook's Drive (otherwise Ashley Road) from Hale Road to Davenport Green.

Parish of Styal-

Wilmslow Road from Norcliffe Farm to Twinnies Bridge at the boundary of the Urban District of Wilmslow.

- 4. To prescribe the maximum price or maximum prices that may be demanded and taken by the Company in respect of the supply of electrical energy within the added area.
- 5. To confer upon the Company all or some of the powers of the Electricity (Supply) Acts 1882 to 1922, and enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for carrying such objects into effect.

Every local or other authority, company or person desirous of bringing before the Electricity Commissioners any objection respecting the application must do so by registered letter addressed to the Secretary, Electricity Commission, Savoy Court, Strand, London, W.C. 2, and despatched, on or before the 3rd day of January, 1927, and a copy of such objection must also be forwarded to the undersigned Solicitors or Parliamentary Agents.
