

## FIRST SCHEDULE.

*Contracted Infected Area.*

## 3. An Area comprising:—

*In the county of Norfolk.*

The parishes of Wacton, Stratton St. Mary, Aslacton, Tivetshall St. Margaret and Moulton St. Michael; such part of the parish of Pulham St. Mary Magdalene as lies to the north of the railway line from Tivetshall Station to Harleston Station, and also such parts of the parishes of Forncett St. Peter and Tharston as lie to the east and south of the following boundary, namely:—

Commencing at the most northerly point of the parish of Aslacton, thence in a north westerly direction along the Forncett St. Peter parish boundary to the Sallow Bridge, thence in an easterly direction along Sandpit Lane and Mill Lane, thence in a direct northerly direction along the road leading to Forncett St. Mary as far as the parish boundary, following the parish boundary to where it meets the road running from Forncett Station to Long Stratton, thence following the said road in a south-easterly direction to the parish boundary, via Ciudad Rodrigo and Swan Lane.

## SECOND SCHEDULE.

*Contracted Infected Area.*

## 4. An Area comprising:—

*In the county of Wilts.*

Such parts of the parishes of Froxfield, Chilton Foliat, Ramsbury, Aldbourne, Baydon and Little Bedwyn as lie within the following boundary, namely:—

Commencing at a point where the county boundary of Berkshire and Wiltshire crosses the main road from Marlborough to Hungerford, thence in a northerly direction along the said county boundary to the point where it crosses the Roman Road between Baydon and Wickham; thence following the said road in a westerly direction as far as Baydon village; thence in a generally southerly direction along the road from Baydon to Ramsbury Manor Park Lodge via Aldbourne, Stock Lane, Upper Axford, Burney Farm and White's Hill; thence continuing in a southerly direction along the road from Ramsbury Manor Park Lodge to a point where it meets the main Marlborough-Hungerford road via Park Farm and Knowle Barn; thence along the latter road in an easterly direction to the point of commencement.

2nd December ...	<i>Kent.</i> All the buildings and lands at Hayton Manor, in the occupation of William and Henry Willmer, in the parish of Stanford, in the administrative county of Kent.
	<i>Denbighshire.</i> The farm buildings, yard and pasture land known as Bryn Awel Farm, in the occupation of Edward Roberts, in the parish of Llanelian, in the administrative county of Denbigh.
3rd December ...	<i>Shropshire.</i> All the land and buildings known as Grove Farm, in the occupation of Charles Minton, in the parish of Shawbury, in the administrative county of Salop.
6th December ...	<i>Denbighshire.</i> All the land and buildings known as Bryncar Farm ( <i>except the three pasture fields known as the Mountain Fields</i> ), in the joint occupation of Thomas and Edward Roberts, in the parish of Bettws-y-Rhos, in the administrative county of Denbigh.
7th December ...	<i>Shropshire.</i> The lands and buildings known as Battlefield Farm, in the occupation of Robert Richard Jones, in the parish of Battlefield, in the administrative county of Salop.
