BOROUGH OF NEATH.

PUBLIC HEALTH ACT, 1925.

B^Y an Order dated the 25th day of November, 1926, the Minister of Health has repealed the following provisions of the Neath Corporation Act, 1922, for the purpose of bringing that Act into conformity with the Public Health Act, 1925, namely :---

Section 64 (Power to lay pipes in private streets).

Section 78 (Width of new streets).

Section 81 (Prevention and removal of projections over streets).

Section 82 (Erection of bridges).

- Section 83 (For preventing water flowing on footpaths).
- Section 84 (For preventing soil, &c. from being washed into streets).

Section 86 (Continuation of existing street to be deemed new street).

Section 94 (Courts to be flagged and drained). Section 96 (Lopping of trees overhanging highways). Section 100 (Houses infested with vermin to be cleansed).

- Section 101 (Cleansing of verminous persons).
- Section 103 (Defining establishment of a new business for purposes of Section 112 of Public Health Act, 1875).
- Section 104 (No place used for storage, &c. of human food to be used for sleeping place).

So much of Section 105 as is contained in paragraphs (a) and (b) of sub-section (1) of the said Section (For regulating manufacture and sale of ice cream, &c.).

- Section 107 (Rag and bone dealers not to sell food).
- Section 113 (For preventing contact with body of person who has died of infectious disease).
- Section 114 (Removal of person suffering from pulmonary tuberculosis to hospital).
- Section 115 (Power medically to examine inmates of common lodging-houses where infectious disease is supposed to exist).
- Section 116 (Power to close infected common lodging-houses).
- Section 119 (Power to reconstruct drain if laid in contravention of Public Health Act, 1875).
- Section 120 (Soil pipes to be ventilated).
- Section 122 (Prohibiting entry of petroleum, &c. into sewers).
- Section 128 (Power to require specially enlarged sewer in new street).
- Section 129 (Watercourse chocked up to be a nuisance under Public Health Act, 1875).
- Section 130 (Owners to repair and clean culverts).

Section 137 (As to hackney carriages).
