Area (No. 6) described in the First Schedule to that Order.

(2) This Article shall come into operation on the ninth day of January, nineteen hundred and twenty-seven.

Release of Sussex Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 as from the seventeenth day of January, nineteen hundred and twenty-seven.

Short Title.

3. This Order may be cited as the Foot-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1927.

Contracted Infected Area.

An Area comprising:—

Such part of the county of East Sussex as lies within the following boundary, namely:—

Commencing at the Hayward's Heath parish boundary at Butler's Green, thence in a north westerly direction along the road from Hayward's Heath to Cuckfield as far as the Green Cross Inn via Broad Street, South Street and Cuckfield, and continuing in a south westerly direction along the road to Bolney Crossways via Butlers Farm; thence in a southerly direction along the road to Hickstead and Sayers Common as far as the Kings Head Inn at Albourne Green; thence in an easterly direction along the road leading past West Town, continuing through High Street Hurstpierpoint, Hassocks Road and Wickham Hill to Hassocks; thence along Station Road and Keymer Road as far as Keymer village and then on to the cross roads at Ditchling; from thence continuing in an easterly direction to a point where the road from Keymer and Ditchling joins the eastern boundary of the parish of Ditchling; thence in a northerly direction along the said parish boundary to the point where it meets the road skirting the northern edge of Blackbrook Wood; thence easterly along the latter road to the point where it meets the road leading to North America and Wivelsfield; thence northerly along the last mentioned road to the point where it joins the Wivelsfield parish boundary at North America, thence turning east along the said parish boundary and then in generally northerly and westerly directions along the Wivelsfield and Hayward's Heath parish boundaries to the point of commencement at Butler's Green.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (DATED 1ST JANUARY, 1927.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Part I of Sheep (Double Dipping) Order of 1920.

1.—(1) Part I (Restriction on Movement of Sheep out of a Movement Area) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "the Principal Order," is hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area for the purposes of that Order.

(2) This Article shall come into operation on the twenty-eighth day of January, nineteen

hundred and twenty-seven.

Application of Part II of Sheep (Double Dipping) Order of 1920.

2. Part II (Double Dipping of Sheep in a Double Dipping Area) of the Principal Order is also hereby applied to the Area described in the Schedule hereto, which shall be also a Double Dipping Area for the purposes of that Order.

Period Prescribed as Double Dipping Period.

3. The dates between which all sheep in the Area described in the Schedule hereto are to be double dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part II of the Principal Order, are hereby fixed to be the fifteenth day of July and the thirty-first day of August in each year.

Revocation of certain Order.

4. The Order of the Minister (No. 4377) dated the twenty-ninth day of December, nineteen hundred and twenty-six, is hereby revoked.
