

Parish of Stanway—

The London Main Road (from the Colchester borough boundary to Beacon End Farm).

Rural District of Maldon—

Parish of Tolleshunt Knights—

The road from Tolleshunt Knights to Tiptree from the War Memorial at Tiptree to St. Luke's Chase.

Urban District of West Mersea—

High Street; the road from High Street via Yewtree House to St. Peter's Road; Yorick Road (from High Street to Beach Road); Beach Road; Barfield Road.

Urban District of Brightlingsea—

Wellington Street; Station Road; Colne Road; New Street; High Street.

Urban District of Wivenhoe—

High Street; Park Road; Station Road; East Street; West Street; Queen's Road; Angelsea Road.

In the County of East Suffolk—

Rural District of Samford—

Parish of East Bergholt—

The main street of East Bergholt from Richardson's Farm to St. Mary's Church, and from St. Mary's Church along the Catterwade Road to the Flatford Mill Road.

9. To authorise the Corporation to open and break up in the added area the following streets and parts of streets which are not repairable by the local authority (namely):—

(A) *Main Roads.*

In the County of Essex—

Rural district of Lexden and Winstree—

The Colchester—Mersea main road from the Colchester borough boundary through the parishes of East Donyland, Langenhoe, Abberton and Peldon to the boundary of the urban district of West Mersea; the Colchester—Layer—Goldhanger main road from the Colchester borough boundary through the parishes of Layer-de-la-Hay, Layer Breton, Great Wigborough, Virley and Salcott to the boundary of the parish of Tolleshunt Knights; the Colchester—Tiptree—Maldon main road from the Colchester borough boundary through the parishes of Stanway, Birch, Layer Marney, Messing and Inworth to the boundary of the parish of Tolleshunt D'Arcy; the London—Ipswich main road from the Colchester borough boundary through the parishes of Stanway, Copford, Aldham and Marks Tey to the boundary of the area of supply in the parish of Eastthorpe; the Colchester—Bures main road from the Colchester borough boundary through the parishes of West Bergholt and Wormingford to the boundary of the area of supply in the parish of Mount Bures; the Colchester—Nayland main road from the Colchester borough boundary through the parish of Great Horksley to the boundary of the area of supply; the London—Ipswich main road from the Colchester borough

boundary through the parishes of Langham and Dedham to the county boundary; the Marks Tey—Braintree—Coggeshall main road from its junction with the London main road at Marks Tey, through the parishes of Marks Tey and Little Tey to the boundary of the area of supply in the parish of Great Tey; main road known as Station Road, Marks Tey, from its junction with the London main road at Marks Tey to Marks Tey Station; the Kelvedon—Tollesbury main road from the Inworth parish boundary through the parish of Messing to the boundary of the parish of Tolleshunt Knights; the Birch—Goldhanger main road from its junction with the Colchester—Tiptree—Maldon main road at Birch Post Office through the parishes of Birch and Layer Breton to the junction with the Colchester—Layer—Goldhanger main road in the parish of Layer Breton; the Colchester—Halstead main road from the Colchester borough boundary through the parishes of Stanway, Copford, Aldham, Fordham, and Chappel to the boundary of the area of supply in the parish of Wakes Colne; roadway on the bridge over the Roman River in the parish of Fingringhoe.

Rural district of Tendring—

The London—Ipswich main road from the Colchester borough boundary through the parish of Ardleigh to the junction of the parishes of Langham and Dedham; the Colchester—Manningtree—Harwich main road from the Colchester borough boundary through the parishes of Ardleigh, Lawford, Manningtree, Mistley, Bradfield, Wix and Wrabness to the boundary of the area of supply in the parish of Ramsey; main road (Manningtree Station Road) from the last-mentioned main road to Manningtree Station, thence eastward to the main road again in the parish of Mistley; the Colchester—Clacton main road from the boundary of the Urban District of Wivenhoe through the parishes of Elmstead, Frating, Great Bentley, Little Bentley, Tendring, Weeley and Little Clacton to the boundary of the area of supply; the Weeley—Walton main road from Weeley through the parishes of Weeley and Thorpe-le-Soken to the boundary of the area of supply in the parish of Kirby at its junction with the urban district of Walton-on-the-Naze; the Thorpe Cross—Frinton main road from Thorpe-le-Soken through the parish of Thorpe-le-Soken to the boundary of the area of supply in the parish of Kirby at its junction with the urban district of Frinton-on-Sea; the Dedham—Ardleigh—Brightlingsea main road from the boundary of the parish of Dedham through the parishes of Ardleigh, Great Bromley, Frating and Thorington to the boundary of the urban district of Brightlingsea; the Colchester—Horseley Cross—Harwich main road from Elmstead Market through the
