#### SURBITON.

Whereas the Urban District Council of Surbiton (hereinafter called the Council) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Surbiton Improvement Act, 1855, so as:—

(1) To repeal section 1 of the said Local Act in so far as the said section incorporates the following sections of the Towns Improvement Clauses Act, 1847, namely:—

*Section 33* (in so far as the section relates to drains required for the drainage of such buildings as are the subject of the Council's byelaws with respect to new streets and buildings).

*Sections 36 to 41* (as to drainage of houses).

*Sections 42 and 43* (in so far as those sections require any ashpit or privy to be constructed to the satisfaction of the Council).

*Section 63* (as to width of new streets).

*Sections 84 to 86* (in so far as those sections relate to procedure in connection with or consequent upon the fixing of the level of any new street).

*Section 109* in so far as that section requires partly walls of buildings to be carried above the roof to form a parapet.

*Sections 110 to 112* (as to supplying buildings with fresh air).

(2) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said District as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application:

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the seventh day of February, 1927, by any person interested in the subject-matter of the said Application and the proposed Provisional Order. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, S.W. 1, and copies of them should be sent at the same time to the Clerk to the Urban District Council, District Council Offices, Surbiton.
