The following Statute made by the University of Oxford, on the 15th day of March, 1927, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923 ":—

UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, MARCH 15, 1927.

Whereas it is expedient to amend Sectio I. § 1. cl. 7 of Titulus XII of the Statutes of the University of Oxford in certain respects, and in particular to provide that persons holding office as members of a University Board shall not cease to hold such office by reason of attaining the age of seventy years:

Now the said University in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:—

In Statt. Tit. XII. Sect. I. § 1. cl. 7 (Statuta, ed. 1926, p. 242) the words from the beginning of the clause to "of that Council present and voting" shall be struck out and the following words shall be substituted :---

"No person who has exceeded the age of 70 years shall be appointed a member of a University Board, provided that a member of a University Board who is over the age of 70 years but has not attained the age of 75 years at the time when the period for which he was last appointed expires may be reappointed by a vote of the appointing Body carried by not less than two-thirds of the members of that Body present and voting, or, in the case of the appointment of such member being vested in a single person or in two persons only, may be reappointed by that person or those two persons provided that such reappointment is approved by a vote of the Hebdomadal Council carried by not less than two-thirds of the members of that Council present and voting."
