Electricity Commission.—1927.

TONBRIDGE ELECTRICITY
 (EXTENSION).

NOTICE is hereby given that the Urban District Council of the Urban District of Tonbridge (hereinafter called "the Council") whose address is at Tonbridge Castle Tonbridge in the County of Kent have applied to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1926 for a Special Order (hereinafter called "the Order") for all or some of the following objects (that is to say):—

1. To extend the area of supply under the Tonbridge Electric Lighting Order 1897 (hereinafter called "the principal Order") so as to include the Parish of Hildenborough in the Rural District of Tonbridge and the portion of the Parish of Leigh which lies to the north of the Tonbridge-Redhill Section of the Southern Railway in the Rural District of Sevenoaks (hereinafter referred to as "the added area") and to authorise the Council to supply and distribute electricity for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1926 within the added area.

2. To extend and make applicable to the added area with or without amendment all or some of the provisions contained in the Principal Order and to apply such provisions to the undertaking to be authorised by the Order subject to such variations and exceptions as may be contained therein.

3. To incorporate with the Order such of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act 1899 as are applicable, and to apply such provisions to the undertaking authorised by the Principal Order or to be authorised by the Order subject to such variations and exceptions as may be contained therein.

4. To authorise the Council to break up in the added area the following streets and parts of streets which are not repairable by the local authority, namely:—

(A) *Main Roads*:—

In the Parish of Hildenborough—
 London Road, Station Road.

In the Parish of Leigh—
 Bid Bridge-Chiddingstone Road.
