MERCHANDISE MARKS ACT, 1926.

'THE MERCHANDISE MARKS EXEMPTION DIRECTION (No. 2), 1927, DATED JUNE 28, 1927, MADE BY THE BOARD OF TRADE UNDER SECTION 1, SUBSECTION (3), OF THE MERCHANDISE MARKS ACT, 1926 (16 & 17 GEO. V, c. 53).

Whereas the Merchandise Marks Act, 1926 (16 & 17 Geo. V, c. 53), Section 1, provides that it shall not be lawful to sell, expose for sale, or, by way of advertising goods of some other kind, distribute, in the United Kingdom, any imported goods to which there is applied any name or trade mark being, or purporting to be, the name or trade mark of any manufacturer, dealer or trader, or the name of any place or district in the United Kingdom, unless the name or trade mark is accompanied by an indication of origin :

And whereas Subsection (3) of the said Section 1 provides that if the Board of Trade are satisfied after considering such representations (if any) as may be made to them by any persons appearing to the Board of Trade to have a substantial interest in the matter, that, having regard to the special circumstances of the trade, difficulties would arise if the said Section 1 applied to goods of any class or description, or goods sold under any particular designation, and that public interests in the United Kingdom would not be materially prejudiced by exempting such goods from the operation of the said Section 1, they may direct that the said Section 1 shall not apply to such goods, or that goods shall not be treated as falling under the said Section 1 by reason only that they are so designated :

Now, therefore, the Board of Trade, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter and being satisfied that, having regard to the special circumstances of the trade, difficulties would arise if the said Section 1 applied to the Uncompounded Drugs hereinafter mentioned, and that public interests in the United Kingdom would not be materially prejudiced by exempting such Drugs from the operation of the said Section 1, hereby direct in pursuance of the powers conferred upon them by the said Subsection (3) as follows :—

1. Section 1 of the Merchandise Marks Act, 1926, shall not apply to Uncompounded Drugs from whatever source derived which are sold for medicinal purposes: Provided that this Direction shall not extend to any such drugs if sold or exposed for sale under a proprietary name.

2. This Direction may be cited as the Merchandise Marks Exemption Direction (No. 2), 1927.

The district referred to above means the area situate in the West Riding of the County of York and in the Counties of Nottingham and Derby comprised within the following boundaries, that is to say:

(a) From Dunford Bridge Station on the Great Central Railway of the London & North Eastern Railway, to Hazlehead Station on the same Railway; thence in a straight line northeast to the centre of the Village of West Bretton ; thence in a straight line to the centre of the Village of Ryhill; thence in a straight line south-east through the Parish Church of South Kirkby until such line reaches the Swinton and Knottingley Joint Railway line; thence in a straight line north-east to the River Ouse after passing through the Parish Church of Drax; thence along the centre of the River Ouse to the point where the Rivers Ouse and Trent join; thence along the centre of the River Trent down to the point at which the Leverton (Great Central) Branch of the London & North Eastern Railway crosses the River Trent near Torksey; thence in a straight line in a westerly direction to Apley-head Lodge on the road from Ranby to Ollerton; thence in a straight line to a point where the County boundary between Nottinghamshire and Yorkshire crosses the road from Harthill to Nitticarhill and Clowne; thence along the boundary of the County of York to
