**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 28th day of July, 1927, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the union of the Benefice (being a Rectory) of Charwelton and the Benefice (being a Vicarage) of Fawsley, both of which Benefices are situate in the County of Northampton and in the Diocese of Peterborough:

“ Whereas Commissioners appointed at our request by the Right Reverend Cyril, late Bishop of Peterborough, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Charwelton and Fawsley duly made their Report to the said Bishop of Peterborough and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Peterborough signified in writing his approval of the said Report:

“ And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

“ And whereas both of the said two Benefices of Charwelton and Fawsley are now full the Reverend Francis Williams Allen being the present Incumbent thereof:

“ And whereas the said Francis Williams Allen has consented to become the first Incum-

bent of the United Benefice, if and when the union which is hereinafter recommended and proposed shall take effect:

“ And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said two Benefices of Charwelton and Fawsley now belongs to one and the same Patron or Patrons:

“ Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the Right Reverend Claude, now Bishop of Peterborough (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ 1. That the said Benefice of Charwelton and the said Benefice of Fawsley shall be permanently united together and form one Benefice with cure of souls under the style of ‘ The United Benefice of Charwelton with Fawsley ’ but the Parishes of the said Benefices shall continue distinct in all respects.

“ 2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the union shall forthwith take effect and the said Francis Williams Allen if he is then Incumbent of the said Benefices of Charwelton and Fawsley shall be the first Incumbent of the United Benefice.

“ Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.”

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:
