HAT, CAP AND MILLINERY TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Hat, Cap and Millinery Trade Board (England and Wales) HEREBY GIVE NOTICE that they PROPOSE TO VARY the General Minimum Time-Rates and Piece-Work Basis Time Rates (and the Overtime Rates based thereon) for certain classes of Male Workers, and the General Minimum Time-Rates (and the Overtime Rates based thereon) for certain Classes of Female Workers, set out in the Trade Boards Notice H.M. (12), dated 19th December, 1923.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 11th day of October, 1927. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Hat, Cap and Millinery Trade Board (England and Wales), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that Objections should state precisely and show as far as possible, with reasons, what is objected to.
