And whereas an Order in Council was made on the 8th day of June, 1854, directing the discontinuance of burials, in, amongst other places, the City and County of the City of Norwich:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the said Order in Council of the 8th day of June, 1854, in so far as it affects burials in the Cathedral Burial Ground of the City of Norwich should be varied:

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the said Order shall have effect subject to the following exception or qualification, viz.:—

That, notwithstanding anything in the said Order in Council of the 8th day of June, 1854, it shall be lawful to bury the body of the late Very Reverend John Wakefield Willink, Dean of Norwich, in the Cathedral Burial Ground of the City of Norwich, and also in the same grave the body of the widow of the said late Dean at her decease.
