## BRIGHTON.

Whereas the Mayor, Aldermen and Burgesses of the Borough of Brighton (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend section 35 of the Brighton Improvement Act, 1884, so as :—

(1) To empower the Corporation to acquire by agreement or to extinguish the rights of the owners and occupiers of the privileged houses and their respective families, visitors and friends under the said section in relation to the user and enjoyment of the undermentioned parts of the enclosed places known as Norfolk Square and New Steine namely (the said pieces of land being required for the widening of Western Road, St. James' Street and Marine Parade) :—

(a) A piece of land at the north end of Norfolk Square enclosure fronting to Western Road, and containing an area of 335 square yards or thereabouts;

(b) A piece of land at the South end of New Steine enclosure fronting to Marine Parade and containing an area of 215 square yards or thereabouts;

(c) A piece of land at the North end of New Steine enclosure fronting to St. James' Street and containing an area of 222 square yards or thereabouts;

(2) To authorise the Corporation to appropriate the said parts of Norfolk Square, and New Steine enclosures for the purpose of widening and improving Western Road, St. James' Street and Marine Parade, respectively;

(3) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that H. A. de Montmorency, Esq., O.B.E., one of the Inspectors of the Ministry of Health will attend at the Town Hall, Brighton, on Friday, the thirtieth day of December, 1927, at two o'clock in the afternoon, to hold a Local Inquiry into the subject-matter of the said Application and the proposed Provisional Order.

And notice is hereby further given that any person interested may attend at such Inquiry and be heard with reference to the said Application and the proposed Provisional Order, and that plans showing the parts of Norfolk Square and New Steine enclosures proposed to be appropriated as aforesaid may be inspected at the Town Hall, Brighton, on
