ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES

(DATED 13TH JANUARY, 1928.)

MIDLANDS AND NORTH OF ENGLAND (FOOT-AND-MOUTH DISEASE) (CONTROLLED AREA) ORDER OF 1928 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of Controlled Area.

1. The Midlands and North of England (Foot-and-Mouth Disease) (Controlled Area) Order of 1927, as amended by the Midlands and North of England (Foot-and-Mouth Disease) (Controlled Area) Order of 1928 shall be read and have effect as if the Area described in the Schedule to this Order were excluded from and ceased to form part of the Controlled Area described in the First Schedule to that Order.

Short Title and Commencement.

2. This Order may be cited as the MIDLANDS AND NORTH OF ENGLAND (FOOT-AND-MOUTH DISEASE) (CONTROLLED AREA) ORDER OF 1928 (No. 2) and shall come into operation on the nineteenth day of January, nineteen hundred and twenty-eight.
