In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Jute Trade Board (Great Britain), HEREBY GIVE NOTICE that they PROPOSE TO VARY the Minimum Rates of Wages for male and female workers set out in the Notice J.
