CINEMATOGRAPH FILMS.

(REGISTRATION).

The Cinematograph Films (Registration) (Amendment) Regulations, 1928, dated March 12, 1928, made by the Board of Trade under Section 29 of the Cinematograph Films Act, 1927 (17 and 18 Geo. V, c. 29).

In pursuance of the provisions of Section 29 of the Cinematograph Films Act, 1927, the Board of Trade hereby make the following Regulations:—

1. Notwithstanding anything in paragraph 3 of the Cinematograph Films (Registration) Regulations, 1927 (S.R. & O. 1927, No. 1201) the fee payable on an application for the registration of a film the length of which is less than one thousand feet shall be half a guinea.

2. These Regulations may be cited as the Cinematograph Films (Registration) (Amendment) Regulations, 1928.

IN THE MATTER OF THE BANKRUPTCY ACT, 1914.

Whereas the Board of Trade by minute dated the 15th February, 1928, appointed Mr. Frederick Murgatroyd to be Senior Official Receiver, and Mr. John Davis Turner to be Official Receiver for the Bankruptcy Districts of the County Courts holden at Manchester, Bolton, Ashton-under-Lyne and Stalybridge, Oldham, Rochdale, Stockport, and Salford, such appointments to take effect from the 9th March, 1928,

And whereas by a Direction dated the 26th April, 1926, the Board of Trade provided for the assignment as therein mentioned of Receiving Orders made by the said Courts to Mr. John Grant Gibson (then Senior Official Receiver but now retired) and to Mr. Frederick Murgatroyd,

Now therefore the Board of Trade, by virtue of Rule 308 of the Bankruptcy Rules, 1915, hereby direct that where Receiving Orders have been made by the said County Courts holden at Manchester and Salford, respectively, prior to the 9th March, 1928, and are pending at that date, and where Receiving Orders are made on and after the 9th March, 1928, by the last mentioned County Courts respectively, Mr. Frederick Murgatroyd shall be the Official Receiver for the purposes of

such Receiving Orders and the estates thereunder shall be assigned to him, and the Board of Trade hereby direct that where Receiving Orders have been made by the said County Courts holden at Bolton, Ashton-under-Lyne and Stalybridge, Oldham, Rochdale, and Stockport, respectively, prior to the 9th March, 1928, and are pending at that date, and where Receiving Orders are made on and after the 9th March, 1928, by the last mentioned County Court respectively, Mr. John Davis Turner shall be the Official Receiver for the purposes of such Receiving Orders and the estates thereunder shall be assigned to him.

This direction shall have effect as from and including the 9th March, 1928, and the said direction dated the 26th April, 1926, above referred to, as from and including the said 9th March, 1928, is hereby cancelled accordingly.

SECTION 33—SAFETY LAMPS.

The Secretary for Mines announces that on the 13th day of March, 1928, he made an Order under Section 33 of the Coal Mines Act, 1911, as amended by the Coal Mines General Regulations (Safety Lamps), 1927, approving for use in all Mines to which the Act applies, subject to the conditions specified in the Schedule to the Order, the following type of Firedamp Indicator Lamp, viz.:—

“RINGROSE (FIREDAMP ALARM).”
