

" That the Inhabitants of such part of the Parish of Hallow as is hereby proposed to be united to the Parish of Saint Clement shall be entitled to benefit from all the Charities connected with the Parish of Hallow in the same manner and to the same extent as previously to being united to the Parish of Saint Clement, and such inhabitants shall be entitled to elect two Trustees of the said Charities as at present.

" That nothing in this Scheme shall be so construed as to limit the right of the inhabitants of the said separated district of Hallow of burial in the Churchyard of the Parish of Hallow.

" That the Parishioners of such respective Districts shall be exonerated from all liability to repair the Churches of the Parishes from which such Districts shall respectively have been separated but shall be entitled to accommodation in the Churches of the Parishes to which such Districts shall be respectively annexed and shall be liable to the repairs of such Churches respectively, but subject to the provisions of the Compulsory Church Rate Abolition Act, 1868.

" That the yearly stipend of £60 13s. 8d. which the Ecclesiastical Commissioners make in respect of a yearly stipend of £30 granted by them in 1901, and also in respect of a Benefaction of £1,000 paid to them in that year towards providing a stipend for an Assistant Curate to be employed in the Parish of Hallow be transferred to the Parish of Saint Clement towards providing a stipend for an Assistant Curate to be employed in that Parish.

" No alteration shall be made in the Patronage or endowments of any of the above mentioned Benefices.

#### " CONSENTS.

" We, The Right Reverend Ernest, Lord Bishop of Worcester, and The Very Reverend William Moore Ede, D.D., Dean of the Cathedral Church of Christ and the Blessed Mary the Virgin of Worcester and the Chapter of the same Church, being the Patrons or persons entitled to alternately present to the United Benefice of Saint Andrew and All Saints in the City and Diocese of Worcester, the said Dean and Chapter of the said Cathedral Church, being the Patrons or persons entitled to present to the Benefices of Saint Clement and Saint John-in-Bedwardine in the said City and Diocese, and the said Lord Bishop of Worcester, being the Patron or person entitled to present to the Benefice of Hallow in the County and Diocese of Worcester, in case any of such Benefices were now vacant.

The Reverend Robert George Kenrick Farmer Philpott, the Incumbent of the said United Benefice of Saint Andrew and All Saints, The Reverend Reginald Fraser Diggle, the Incumbent of the said Benefice of Saint Clement, and The Reverend Joseph Holden Stallard, the Incumbent of the said Benefice of Hallow, do hereby respectively signify to Your Grace our several Consents to the Scheme above proposed and set forth and to every matter therein contained.
