

Electricity Commission—May, 1928.

YORK ELECTRICITY (EXTENSION).

(The supply of Electricity by the Lord Mayor, Aldermen and Citizens of the City of York in parts of the Rural Districts of Escrick and Pocklington in the East Riding, Easingwold, Flaxton and Malton in the North Riding, and Great Ouseburn in the West Riding of the County of York.)

NOTICE is hereby given that the Lord Mayor, Aldermen and Citizens of the City of York (who are hereinafter referred to as "the Corporation") and whose address is the Guildhall, York), intend to apply to the Electricity Commissioners for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts, 1882 to 1926, for all or some of the following, amongst other purposes (that is to say):—

1. To extend further the area of supply of the Corporation under the York Electric Lighting Order 1890 (hereinafter called "the Order of 1890") as extended by the York Electric Lighting (Extension) Order 1914 (hereinafter called "the Order of 1914") so as to include therein—

In the East Riding of the County of York:—

The parish of Stamford Bridge West with Scoreby in the rural district of Escrick.

The parish of Stamford Bridge East in the rural district of Pocklington.

In the North Riding of the County of York:—

The parishes of Aldwark, Alne, Brafferton, Bransby - cum - Stearsby, Crayke, Dalby-cum-Skewsby, Easingwold, Farlington, Flawith, Helperby, Huby, Marton-cum-Moxby, Myton-on-Swale, Raskelf, Stillington, Sutton-on-Forest, Tholthorpe, Tollerton, Whenby and Youlton in the rural district of Easingwold.

The parishes of Bossall-with-Buttercrambe, Claxton, Flaxton, Gate Helmsley, Harton, Lillings Ambo, Sand Hutton and Upper Helmsley in the rural district of Flaxton.

The parishes of Barton-le-Willows, Bulmer, Crambe, Foston, Ganthorpe, Henderskelfe, Huttons Ambo, Sheriff Hutton with Cornborough, Stittenham, Terrington with Wigganhorpe, Thornton-le-Clay, Welburn and Whitwell-on-the-Hill in the rural district of Malton.

In the West Riding of the County of York:—

The parishes of Caftal, Great Ouseburn, Green Hammerton, Kirby Hall, Kirk Hammerton, Little Ouseburn, Lower Dunsforth, Marton-cum-Grafton, Nun Monkton, Thornville, Thorpe Underwoods, Upper Dunsforth with Branton Green, Whixley, Widdington, and so much of the parish of Aldborough as is outside a radius of one and a half miles from St. James' Church, Boroughbridge in the rural district of Great Ouseburn.

(the said area of supply as proposed to be extended being hereinafter referred to as "the

extended area of supply") and to authorise the Corporation to supply, distribute and sell electrical energy for public and private purposes as defined by the said Acts within the extended area of supply.

2. To extend and make applicable to the extended area of supply all or some of the provisions contained in the Order of 1890 the Order of 1914 and the York Corporation Acts 1902, 1913 and 1914 and to apply such provisions to the undertaking to be authorised by the Order, subject to such variations and exceptions as may be contained therein and to repeal or amend so far as may be deemed expedient any orders made by the Board of Trade and the Electricity Commissioners under the provisions of section 6 of the Electric Lighting Act, 1909, in relation to the supply of electricity by the Corporation to any premises within the extended area of supply.

3. To exclude from incorporation some or all of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act, 1899, or to incorporate the same with such modifications and exceptions as may be indicated in the Order.

4. To confer upon the Corporation all or some of the powers of the Electricity (Supply) Acts, 1882 to 1926, and enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would or might interfere with any of the objects of the Order and to confer all other rights and privileges necessary for carrying such objects into effect.

5. To prescribe the maximum price that may be demanded and taken by the Corporation in respect of the supply of electricity within the extended area of supply.

6. The streets and parts of streets in which it is proposed that electric lines shall be laid down within a sepecified time are:—

In the North Riding of the County of York:—

Rural District of Easingwold:—

Parish of Alne—

Main Street from its junction with Back Lane, to a point 700 yards or thereabouts south west thereof.

Parish of Tollerton—

York Bridge Road from a point near the Smithy at the east end of the Village to the junction of that road with Main Street.

Running Sykes Bank from its junction with Main Street to a point 200 yards or thereabouts west thereof.

Main Street from its junction with York Bridge Road to a point 425 yards or thereabouts south west thereof.

7. To authorise the Corporation to open and break up the following streets and parts of streets which are not repairable by the local authority and railways in the extended area of supply, viz.:—

Streets:—

In the East Riding of the County of York:—

Rural District of Pocklington—

The York to Hull Main Road from the North Riding boundary in the parish of Stamford Bridge West with Scoreby to the eastern boundary of the parish of Stamford Bridge East.
