" All that portion of the said New Parish of Saint Mary Magdalen, Milnshaw, Accrington, which is bounded upon the south west and upon the south east by the said New Parish of Saint James, Accrington, upon the north east by the New Parish of Saint John the Evangelist, Accrington, in the said County and Diocese, and upon the remaining side, that is to say, upon the north, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint John the Evangelist, Accrington, from the said New Parish of Saint Mary Magdalen, Milnshaw, Accrington, at the junction of Whalley Road with Kenyon Street, and extending thence first south westward, and then north westward along the middle of Kenyon Street for a distance of 81 chains or thereabouts to its junction with King Street, and extending thence south westward along the middle of King Street for a distance of 20 yards or thereabouts to the centre of the bridge which carries King Street across the River Hyndburn upon the boundary which divides the said New Parish of Saint Mary Magdalen, Milnshaw, Accrington, from the said New Parish of Saint James, Accrington.

" The Second Schedule.

"The territory to be dissevered from the said New Parish of Saint John the Evangelist, Accrington, and to be annexed to the said New Parish of Saint Mary Magdalen, Milnshaw, Accrington, being :---

"All that portion of the said New Parish of Saint John the Evangelist, Accrington, which is bounded upon the north by the Chapelry of Altham, in the said County and Diocese, upon the west by the said New Parish of Saint Mary Magdalen, Milnshaw, Accrington, and upon the remaining sides, that is to say, upon the south and upon the east, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mary Magdalen, Milnshaw, Accring-ton, from the said New Parish of Saint John the Evangelist, Accrington, at the junction of Whalley Road with Owen Street, and extending thence north eastward along the middle of Owen Street for a distance of $5\frac{1}{2}$ chains or thereabouts to its junction with Haywood Street, and extending thence northward along the middle of Haywood Street for a distance of 121 chains or thereabouts to its junction with Queen's Road and Haywood Road, and extending thence northward along the middle of Haywood Road for a distance of $27\frac{1}{2}$ chains or thereabouts to its junction with Livingstone Road, and continuing thence in precisely the same direction and in a straight line to a point near the northern side of Livingstone Road upon the boundary which divides the said New Parish of Saint John the Evangelist, Accrington, from the said Chapelry of Altham.

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto: And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Blackburn.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Great Whelnetham, in the County of Suffolk and in the Diocese of Saint Edmundsbury and Ipswich:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Great Whelnetham is vested for an estate in fee simple without incumbrances in the Saint Edmundsbury and Ipswich Diocesan Board of Finance whose registered Office is at Diocesan House, Tower Street, Ipswich, in the said County of Suffolk:

"And whereas the said Saint Edmundsbury and Ipswich Diocesan Board of Finance are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Great Whelnetham, now vested in them as aforesaid, should be
