

At the Court at *Buckingham Palace*, the 7th day of *May*, 1928.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 15th day of March, 1928, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Vicarage) of Louth (Saint James) and the Benefice (being a Rectory) of Welton le Wold, both of which Benefices are situate in the County of Lincoln and in the Diocese of Lincoln :

“ Whereas Commissioners appointed at our request by the Right Reverend William Shuckburgh, Bishop of Lincoln, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Louth (Saint James) and Welton le Wold duly made their Report to the said Bishop of Lincoln and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Lincoln signified in writing his approval of the said Report :

“ And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report :

“ And whereas the said Benefice of Louth (Saint James) is now full the Reverend Canon Charles Henry Lenton being the present Incumbent thereof and the said Benefice of Welton le Wold is at present vacant :

“ And whereas the said Charles Henry Lenton has consented to become the first Incumbent of the United Benefice, if and when the union which is hereinafter recommended and proposed shall take effect :

“ And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said two Benefices of Louth (Saint James) and Welton le Wold now belongs to one and the same Patron or Patrons :

“ Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said William Shuckburgh, Bishop of Lincoln (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ 1. That the said Benefice of Louth (Saint James) and the said Benefice of Welton le Wold shall be permanently united together and form one Benefice with Cure of Souls under the style of ‘ The United Benefice of Louth with Welton ’ but the Parishes of the said Benefices shall continue distinct in all respects.

“ 2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the

union shall forthwith take effect and the said Charles Henry Lenton if he is then Incumbent of the said Benefice of Louth (Saint James) shall be the first Incumbent of the United Benefice.

“ 3. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Louth (Saint James) shall become and be the house of residence for the Incumbent of the United Benefice.

“ Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.”

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923 :

And whereas certain objections have been so stated or transmitted to the said Ecclesiastical Commissioners within the time prescribed in the same Rules :

And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme :

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Lincoln has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid :

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme :

And whereas the said Scheme has been approved by His Majesty in Council :

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lincoln.
