

TRADE BOARDS ACTS, 1909 AND 1918.

CHAIN TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY AND FIX GENERAL MINIMUM PIECE RATES OF WAGES IN THE HAND HAMMERED CHAIN TRADE FOR PERIODS DEPENDENT UPON THE COST OF LIVING INDEX FIGURE AND TO CANCEL CERTAIN GENERAL MINIMUM PIECE RATES IN THE HAND HAMMERED CHAIN TRADE.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 21st April, 1927, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain, for the trade of Hand Hammered and Dollied or Tommied Chain Making NOW HEREBY GIVE NOTICE that they PROPOSE as respects Hand Hammered Chain made from iron up to and including $\frac{1}{2}$ in., to VARY for periods dependent upon the Cost of Living Index Figure certain of the General Minimum Piece Rates set out in the Notices C. (17) and C. (21) issued by the Trade Board and dated 30th October, 1923 and 21st February, 1925, respectively, and to FIX for periods dependent upon the Cost of Living Index Figure certain additional General Minimum Piece Rates, and to CANCEL certain of the General Minimum Piece Rates set out in the above-mentioned Notices C. (17) and C. (21).

Full particulars of the proposed rates and the proposed cancellations will be supplied on application to the Secretary of the Trade Board by or on behalf of persons engaged in the trade.

Under Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any Objections to the above Proposal to Vary and Fix and Cancel which may be lodged with them within two months from the 12th day of June, 1928. Such Objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to The Secretary, Chain Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1. It is desirable that Objections should state precisely, and so far as possible with reasons, what is objected to.
