Employment by a City Corporation on the alternate week system under a scheme for employing Board of Guardians test men on

public utility work.

Under the Rules of the Supreme Court, Order LV B, Rule 28, any person who claims to be affected by the decision to be given in the above mentioned case may apply to the Judge for leave to intervene.

The case has been set down in the High Court, and it is hoped, will be heard in the

near future.
