

**THE SAFEGUARDING OF INDUSTRIES (EXEMPTION)
No. 4 ORDER, 1928, DATED 4TH JULY, 1928,
MADE BY THE TREASURY UNDER SECTION 10 OF
THE FINANCE ACT, 1926 (16 & 17 GEO. V,
c. 22).**

Whereas it is provided by sub-section (5) of Section 10 of the Finance Act, 1926 (16 & 17 Geo. V, c. 22) that the Treasury may by order exempt from the duty imposed by Section one of the Safeguarding of Industries Act, 1921 (11 & 12 Geo. V, c. 47), as amended by the Finance Act, 1926, for such period as may be specified in the Order, any article in respect of which the Board of Trade are satisfied on a representation made by a consumer of that article that the article is not made in any part of His Majesty's Dominions in quantities which are substantial having regard to the consumption of that article for the time being in the United Kingdom and that there is no reasonable probability that the article will within a reasonable period be made in His Majesty's Dominions in such substantial quantities:

And whereas the Board of Trade are satisfied on representations made by consumers of the articles specified in Article 1 of this Order that those articles are not made in any part of His Majesty's Dominions in quantities which are substantial having regard to the consumption of those articles for the time being in the United Kingdom and that there is no reasonable probability that those articles will within a reasonable period be made in His Majesty's Dominions in such substantial quantities:

Now therefore we, being two the Lords Commissioners of His Majesty's Treasury in pursuance of the powers conferred on us by the said Section 10 of the Finance Act, 1926, and of all other powers enabling us in that behalf hereby order as follows:—

1. Such vanadium - silica compounds specially prepared for use as catalysts for sulphuric acid manufacture as are not entered under the Customs Acts before the 9th day of July, 1928, or which have not been removed from a bonded warehouse before that date, shall be exempt from the duty imposed by Section one of the Safeguarding of Industries Act, 1921, as amended by the Finance Act, 1926, for a period ending on the 31st day of December, 1928.

2. This Order may be cited as the Safeguarding of Industries (Exemption) No. 4 Order, 1928.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts of women of 18 years of age and over at the loading Bank of the Bottling Stores at the works of Messrs. Hoare & Co. Ltd., St. Katherine's Way, Stepney, E. 1, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation shall be provided; and that a woman shall not be allowed to lift, carry or move anything so heavy as to be likely to cause her injury.
