MILK DISTRIBUTIVE TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO FIX MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS NEWLY BROUGHT WITHIN THE SCOPE OF THE TRADE BOARD.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Milk Distributive Trade Board (England and Wales) HEREBY GIVE NOTICE that they PROPOSE TO FIX Minimum Rates of Wages for Male and Female Workers newly brought within the scope of the Trade Board by the Trade Boards (Milk Distributive) Order, 1928.

Particulars of the proposed minimum rates may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will CONSIDER ANY OBJECTIONS to the above Proposal to Fix which may be lodged with them within two months from the 31st July, 1928. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary

His Majesty The KING has been pleased, upon the recommendation of the President of the Board of Trade, to award the Silver Medal for gallantry in Saving Life at Sea (Foreign Services) to the crews of the Dutch lifeboats from Wijk aan Zee, Ymuiden and Nieuwediep, in recognition of the gallantry displayed by them on the 17th and 18th February last in saving, and endeavouring to save, the crew of the British steamship "Shonga," of Liverpool, which was wrecked on the Dutch coast near Ymuiden.

His Majesty The KING has also been pleased, upon the recommendation of the President of the Board of Trade, to award the Bronze Medal for Gallantry in Saving Life at Sea to Harold Walwin Clarke, deckhand, of the steam trawler "Liberia," of Grimsby, in recognition of his gallantry in endeavouring, by swimming with a rope, to assist the crew of the concrete barge "Cretetree," which was in distress off the Orkney Islands on the 30th March last.
