

Notice, dated 21st December, 1928, setting out minimum rates of wages for workers newly brought within the scope of the Trade Board by the Trade Boards (Waste Materials Reclamation Trade, Great Britain) (General Waste Branch) (Amendment) Regulations, 1927 and 1928, which have been fixed to take effect under an Order of the Minister of Labour as from 24th December, 1928. The Notice also sets out all the rates at present effective in the Trade which have not been varied.

COAL MINES ACT, 1911.

The Secretary for Mines gives notice that on the 10th day of December, 1928, he made General Regulations under Sections 85 and 86 of the Coal Mines, Act, 1911, to apply to all mines under that Act in which coal or oil shale is worked and in which the total number of persons employed underground exceeds ten, and relating to rescue and other necessary work in mines after explosion or fire, or otherwise in an atmosphere which may be dangerous to life.

The Regulations, which may be cited as the Coal Mines General Regulations (Rescue) 1928, come into force on the first day of January, 1929.
