to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And do further, by and with the like advice, hereby direct that this Order be forthwith registered by the Registrar of the said Diocese of Durham.

WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 22nd day of November, 1928, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint James, Littlehampton, situate in the Parish of Littlehampton, in the County of Sussex, and in the Diocese of Chichester:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint James, Littlehampton, situate as aforesaid:

"Now, therefore, with the consent of the Right Reverend Winfrid Oldfield, Bishop of Chichester (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Little-hampton which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint James, Littlehampton, situate as aforesaid, and that the same should be named 'The District Chapelry of Saint James, Littlehampton.'

"And with the like consent of the said Winfrid Oldfield, Bishop of Chichester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint James, Littlehampton, situate as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint James, Littlehampton, being:—

"All that part of the Parish of Littlehampton, in the County of Sussex and in the Diocese of Chichester, which is bounded upon the north west by the Parish of Lyminster, upon the south west by the Parish of Clymping, both in the said County and Diocese, and upon the remaining side, that is to say, upon the east by an imaginary line commencing upon the boundary which divides the said Parish of Clymping from the said Parish of Littlehampton at a point in the middle of the River Arun opposite to the middle of the steps leading from Pier Road to the ferry plying across the said river, and extending thence eastward to and along the middle of the said steps for a distance of 12 chains or thereabouts to a point on the western side of Pier Road, and extending thence first eastward to and then northward along the middle of Pier Road for a distance of 16 chains or thereabouts to its junction with Surrey Street, and extending thence northward along the middle of Surrey Street for a distance of 5 chains or thereabouts to its junction with High Street and extending thence eastward along the middle of High Street for a distance of 3 chains or thereabouts to its junction with Duke Street, and extending thence northward along the middle of Duke Street for a distance of
