URBAN DISTRICT OF ERITH.

PUBLIC HEALTH ACT, 1925.

BY an Order made under Section 77 of the Public Health Act, 1925, the Minister of Health has prescribed the rate of interest recoverable by the Urban District Council of Erith in respect of expenses for private street works at 5½ per cent. per annum instead of 5 per cent. per annum. The Order is applicable to expenses incurred by the Council after the 7th day of September, 1925, and finally apportioned by their Surveyor on or after the 14th day of January, 1929.

The Order will cease to have effect, subject as therein mentioned, on the 14th day of January, 1931.

NOTICE is hereby given that by an Order dated the 31st day of December 1928, the Minister of Health has confirmed an Order made on the 12th day of November 1928, by the URBAN DISTRICT COUNCIL OF OTLEY, in the County of York, in pursuance of Section 112 of the Public Health Act 1875, as amended by Section 51 of the Public Health Acts Amendment Act 1907, declaring the trades of a fish frier, a gut scraper, and a rag and bone dealer within the said Urban District to be offensive trades.
