IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 61A) Provisional Regulations, 1929, to come into operation forthwith as provisional regulations to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the operation of an additional omnibus journey on Route No. 61A (Kingston and Esher).

LAND DRAINAGE ACTS, 1861 AND 1918.

RIVER DEE DRAINAGE BOARD.

ALTERATION OF BOUNDARIES, ETC.

Notice is hereby given that the Ministry of Agriculture and Fisheries has prepared a draft Order under the Land Drainage Act, 1918 (1) altering the boundaries of the area under the jurisdiction of the above named Drainage Board by the inclusion therein of approximately 3,000 acres of land lying immediately to the north-west of the present Area H of the Drainage District, and (2) authorising the Drainage Board to enter into arrangements with the River Dee Conservancy Board for certain purposes.

A copy of the draft Order, and a 6 inch scale map showing the proposed alteration of boundaries, have been deposited at the Offices of the Drainage Board, 16, Nicholas Street, Chester, for public inspection for a period of one calendar month from the date hereof.
