Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas by the Burial Act, 1855, it was, amongst other things, enacted that it should be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, should or should not have arrived), as to His Majesty, with such advice as aforesaid, might seem fit:

And whereas an Order in Council was made on the 18th day of October, 1854, directing the discontinuance of burials in, amongst other places, the Parish Church and Churchyard of Saint Mary, Chelmsford:

And whereas an Order in Council was made on the 20th March, 1857, varying the said Order in Council of the 18th October, 1854:

And whereas an Order in Council was made on the 11th October, 1923, varying the said Orders in Council of the 18th October, 1854, and 20th March, 1857:

And whereas by an Order in Council of the 21st day of January, 1914, the Bishopric of Chelmsford was founded and the Parish Church of Chelmsford declared to be the Cathedral Church of the said Bishopric:

And whereas it seems fit to His Majesty, by and with the advice of His Privy Council, that the said Order in Council of the 18th day of October, 1854, as varied by the Orders of the 20th March, 1857, and the 11th October, 1923, in so far as it affects burials in the burial ground of the Cathedral Church of Chelmsford should be further varied:

Now, therefore, Her Majesty The Queen, His Royal Highness The Duke of York, the Lord High Chanceller of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorized thereto by His Majesty's said Commission in pursuance of the said Act of Parliament, and of all other powers enabling them in that behalf, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf are pleased to order, and it is hereby ordered, that the said Orders shall have effect subject to the following exception or qualification, viz.:—

That, notwithstanding anything in the said Orders in Council of the 18th day of October, 1854, and the 20th day of March, 1857, and the 11th day of October, 1923, in a new brick grave in the burial ground attached to the Cathedral Church of Saint Mary, Chelmsford, the burial may be allowed of the body of the late Canon Henry Ashton Lake, Sub-dean of the Cathedral.
