And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Salisbury has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been proceeded with to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Measure against the said Scheme or any part thereof by any person who has made objection as aforesaid to the said draft Scheme:

And whereas the said Scheme has been approved at the Council held under the authority of the said Commission:

Now, therefore, His Royal Highness The Duke of York, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury being authorised Majesty's thereto by His said Commission have taken the said Scheme into consideration, and do hereby, by and with the advice of His Majesty's Privy Council, on His Maiesty's behalf, affirm the said Scheme and order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and do further order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And do further, by and with the like advice, direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.

WHEREAS His Majesty was pleased by His Commission dated the 4th day of December, 1928, to nominate and appoint Her Majesty The Queen, His Royal Highness The Prince of Wales, K.G., K.T., K.P., G.C.S.I., G.C.M.G., G.C.I.E., G.C.V.O., G.B.E., His Royal Highness The Duke of York, K.G., K.T., G.C.M.G., G.C.V.O., the Most Reverend Father in God Cosmo Gordon, Archbishop of Canterbury, the Right Honourable Douglas McGarel, Baron Hailsham, Lord High Chancellor of Great Britain, and the Right Honourable Stanley Baldwin, Prime Minister and First Lord of the Treasury, or any three of them, during His Majesty's illness, to summon and hold on His Majesty's behalf His Privy Council, and to signify thereat His Majesty's

approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared and laid before His Majesty in Council a Scheme bearing date the 21st day of February, 1929, in the words and figures following, that is to say:--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Saint George, Everton, in the County of Lancaster and in the Diocese of Liverpool:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint George, Everton, is vested in the Venerable George Hardwicke Spooner, of Number 23 Grove Park in the City of Liverpool Clerk in Holy Orders and Archdeacon of Liverpool John Cecil Gerard Leigh, of Number 16 Grosvenor Street London W. 1, a Major (Retired) in Your Majesty's Army, and Cuthbert Leigh Blundell Hollinshead Blundell, of Slaugham Place Hayward's Heath in the County of Sussex, a Major (Retired) in Your Majesty's Army, as trustees upon the trusts declared in a Deed bearing date the 31st day of May, 1881, and the said George Hardwicke Spooner, John Cecil Gerard Leigh, and Cuthbert Leigh Blundell Hollinshead Blundell are therefore the Patrons or persons entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said George Hardwicke Spooner, John Cecil Gerard Leigh, and Cuthbert Leigh Blundell Hollinshead Blundell are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint George, Everton, should be transferred to and be vested in the Bishop of Liverpool for the time being:

"And whereas the Right Reverend Albert Augustus, now Bishop of Liverpool, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he the said Albert Augustus, Bishop of Liverpool, has executed this Scheme as hereinafter mentioned:
