- ORDER DEFINING THE BENEFITS OR ADVANTAGES WHICH MAY BE RECKONED AS PAYMENT OF WAGES IN LIEU OF PAYMENT IN CASH.**
- The Dorset Agricultural Wages Committee, in pursuance of the powers vested in them by the Agricultural Wages (Regulation) Act, 1924, and the Regulations made thereunder, do by this Order vary as from 8th April, 1929, their Order of the 16th November, 1928, defining the benefits or advantages (not being benefits or advantages prohibited by law) which may be reckoned as payment of wages in lieu of payment in cash for the purpose of the application of any minimum rate of wages fixed by the said Committee for the area comprising the administrative county of Dorset, so as to provide that such benefits or advan-
