#### COUNTY OF DERBY.

##### THE CORONERS (AMENDMENT) ACT, 1926.

##### ORDER FOR THE CONSTITUTION OF CORONERS' DISTRICTS.

Whereas on the first day of April 1929, a vacancy occurred in the office of Franchise Coroner for the Hundred of Scarsdale;

And whereas by the operation of Section 4 of the Coroners (Amendment) Act, 1926, the area over which the Franchise Coroner for the said Hundred of Scarsdale had jurisdiction thereupon became merged in the County of Derby for all purposes relating to Coroners;

And whereas the County of Derby is not at present divided into Coroners' Districts;

And whereas the Derbyshire County Council have pursuant to Section 12 of the said Act and to the Coroners (Orders as to Districts) Rules, 1927, submitted to the Secretary of State a draft Order providing for the division of the County of Derby into two Coroners' districts;

Now, therefore, I, the undersigned, one of His Majesty's Principal Secretaries of State, in pursuance of the power vested in me by Section 12 of the Coroners (Amendment) Act, 1926, do hereby Order that the County of Derby shall be divided into two Coroners' Districts, and that the said Districts shall be named and constituted as set out in the Schedule hereto.

This Order shall come into operation on the second day of April, 1929.
