FYLDE WATER BOARD.

Whereas the Fylde Water Board (hereinafter called the Board) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Fylde Water Board Act, 1925, so as:—

(1) To authorise the payment to the Consolidated Loans Fund which the Board are empowered by the said Act to establish of any moneys forming part of any superannuation, reserve, accident, renewals, depreciation, contingent or other similar fund, with a view of enabling the Board to use and apply such moneys together with other moneys of the Consolidated Loans Fund in the exercise of any statutory borrowing power or in the redemption of stock or any other securities issued by the Board, the purchase of stock for extinction or the repayment of any moneys borrowed by the Board;

(2) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the district of the Board as may be necessary or desirable;

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the seventeenth day of April, 1929, by any person or body interested in the subject matter of the said Application and the proposed Provisional Order. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, London, S.W. 1, and copies of them should be sent at the same time to the Clerk to the Board, Head Office, Sefton Street, Blackpool.

And notice is hereby further given that a draft of the proposed Provisional Order may be inspected at the Head Office of the Board, as above, on any week-day prior to the said date during ordinary office hours.

MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act to make Regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Croydon Services) Provisional Regulations, 1929, and the London Traffic (Restricted Streets) Amendment (Route No. 58) Provisional Regulations, 1929, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for an alteration in the omnibus services on various routes serving Croydon and district.
