RURAL DISTRICT COUNCIL OF HARTLEY WINTNEY.

PUBLIC HEALTH ACTS AMENDMENT ACT 1907.

By an Order dated the sixteenth day of March, 1929, the Minister of Health has declared that, on and after the eighth day of April, 1929, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Hartley Wintney, namely:—

(a) In all the Contributory Places:—

Sections 34 to 38 inclusive

Sections 43 to 46 inclusive

Sections 48 to 50 inclusive

comprised in Part III (Sanitary Provisions) and Part IV (Infectious Diseases).

(b) In the Contributory Place of Hartley Wintney:—

Sections 39 to 42 inclusive comprised in Part III (Sanitary Provisions).
