FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 20).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:-

Further Contraction of Anerley Foot-and-Mouth Disease Infected Area.

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1929 (No. 18) as amended by the Foot-and-Mouth Disease (Infected Arcas) Order of 1929 (No. 19), shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the last mentioned Order.

(2) This Article shall come into operation on the fifteenth day of April, nineteen hundred and twenty-nine.

Release of Anerley Infected Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the twenty-second day of April, nineteen hundred and twenty-nine.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1929 (No. 20).

Contracted Infected Area.

An Area comprising:-In the county of Kent.

The parish of Penge; and so much of the parish of Beckenham as lies to the north-west of Croydon Road, High Street, Beckenham, Southend Road and Stumps Hill.

In the county of Surrey.

So much of the county borough of Croydon as lies within the following boundary, namely:-

Commencing at the borough boundary at Hermitage Bridge, Norbury, thence southerly along London Road to the point where it is met by St. James' Road; thence in a generally easterly direction along St. James' Road and Lower Addiscombe Road, thence continuing in a north-easterly direction along Long Lane to the point where it crosses the borough boundary at the end of Long Lane  $\mathbf{Wood}.$

QUARANTINE STATIONS (REGULATION) ORDER OF 1929 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:

Provision for movement to London Quarantine Station of Animals landed from Channel Islands.

1.—(1) Subject as herein provided, an animal landed at an Approved Landing Place in Great Britain from the Channel Islands under and in accordance with the provisions of the Animals (Landing from Ireland, Channel Islands and Isle of Man) Order of 1923, may be moved with the licence required under Article 28 of that Order to the premises at East India Dock, London, now in the occupa-tion of the Royal Agricultural Society of England, and approved by the Minister of Agriculture and Fisheries as a quarantine station for the purposes of the Quarantine Stations (Regulation) Order of 1928 (hereinafter referred to as the Principal Order), for the purpose of being re-shipped to a place of destination outside Great Britain after undergoing detention at the said quarantine station in accordance with the provisions of the Principal Order, as modified by this Order.

(2) An animal referred to in this Article shall not be landed at an approved landing place for the aforesaid purpose whilst the landing place is being used for the landing of any other animal or whilst any other animal

remains in the landing place.

(3) Before any animal to which paragraph (1) of this Article applies is landed at an approved landing place the part of the landing place and the gangways and other apparatus and pens, hurdles or other things to be used by the animal shall be cleansed and
