SOUTH WEST NORTHUMBERLAND ELECTRICITY.

NOTICE is hereby given that the Newcastle-upon-Tyne Electric Supply Company Limited whose registered office is at Carlisle House, Newcastle-upon-Tyne (hereinafter referred to as "the Applicants") have applied to the Electricity Commissioners under the Electricity (Supply) Acts, 1882-1926, for a Special Order (hereinafter called "the intended Order") for all or some of the following amongst other purposes, that is to say:—

1.—(a) To authorise the Applicants to supply electricity for all public and private purposes as defined by the above Acts within the following area (hereinafter called "the area of supply"):—

(b) To incorporate with the intended Order (with or without modifications or exemptions) all or any of the provisions of the Electric Lighting (Clauses) Act, 1899, and of the Acts and portions of Acts incorporated therewith and to confer on the Applicants all such powers as may be necessary for effecting the
