

modifications as he thinks fit: And whereas the administrative county of the Parts of Lindsey, Lincolnshire, is now divided into coroners' districts: And whereas the county council of the said county have, pursuant to section 12 of the said recited Act, submitted to the Secretary of State a draft Order providing for the alteration of the divisions of the said county into coroners' districts: and whereas the requirements of the Coroners (Orders as to Districts) Rules, 1927, have been complied with: Now therefore, I, the undersigned, one of His Majesty's Principal Secretaries of State, in pursuance of the power vested in me by section 12 of the said recited Act, do hereby order that the existing division of the administrative county of the Parts of Lindsey, Lincolnshire, into coroners' districts shall be altered and that the said districts shall be named and constituted as set out in the Schedule hereto and substituted for the existing districts.

This Order shall come into operation on the first day of April, 1929.
