THE SALE OF FOOD (REVOCATION) ORDER, 1929, DATED APRIL 18, 1929, MADE BY THE BOARD OF TRADE UNDER THE MINISTRY OF FOOD (CONTINUANCE) ACT, 1920 (10 & 11 GEO. 5, c. 47), THE MINISTRY OF FOOD (CESSATION) Order, 1921 (S.R. & O. 1921, No. 445), and THE EXPIRING LAWS CONTINUANCE ACT, 1928 (19 GEO. 5, c. 3).

In exercise of the powers conferred upon them by the Ministry of Food (Continuance) Act, 1920, the Ministry of Food (Cessation) Order, 1921 (S.R. & O. 1921, No. 445, p. 257), the Expiring Laws Continuance Act, 1928, and of all other powers enabling them in that behalf the Board of Trade hereby order as follows:-

1. Article 8 (relating to the sale of imported eggs) of the Sale of Food Order, 1921 (S.R. & O. 1921, No. 1305), made by the Board of Trade, is hereby revoked but without prejudice to any proceedings in respect of any contravention thereof.

2. This Order may be cited as the Sale of Food (Revocation) Order, 1929, and shall come into operation on the 21st April, 1929.
